I. ESTABLISHMENT OF A QUORUM AND CALL TO ORDER

V. CLARK LANE MIDDLE SCHOOL

VII. OSWEGATCHIE SCHOOL

Architect's Report Oswegatchie School: Jacunski Humes, LLC

Mr. Al Jacunski reported that he is pleased with the progress that is being made on the construction of the school. He said it is about 85% complete and some of the components may be a little ahead of schedule. The Technology and the FF&E packages have gone out to bid on Friday, and as of today seven contractors have picked up the bid package on the Technology Package, and six have picked up the bid package on the FF&E Package. The bid opening is coordinated with Rudie's office for the 17th. The results should be available at the next SBC meeting.

Construction Manager's Report Oswegatchie School: O & G 1. Monthly Progress Report #13

Mr. Gus Kotait showed slides of the progress being made at the Oswegatchie School Project. Slides of the South Elevation, the curtain wall, the main entrance (where the ceilings are done, and the quartz stone floor will be put in), the administration corridor which is carpeted and the ceilings are up, the first and second floor corridors, the classroom window shades and blinds are in, the carpet is installed, the doors are ongoing, the stair tower, the toilet rooms on the first floor have lights that give power to the sinks to turn on the water at the sinks, the fixtures are in, the media center ceilings are up and the floors are done, the nurse's office is carpeted, the gym floor has line striping, the gym equipment is done, pads are needed on the walls after the wood floor is finished. The Cafeteria and stage areas have ceilings and the rubber floor will be put in soon. The gym also has electronic shades which are remote controlled. The exterior security system cameras will be finished soon. Sitework will start around May 1, 2009 on the access road and the demo will be done soon. Mr. Kotait went over the delivery schedule for materials. Mr. Schilling said that the playground bids will be in around May 6th.

VIII. GREAT NECK SCHOOL

Architect's Report Great Neck School: Jacunski Humes, LLC

Mr. Jacunski reported that the early construction and clearing of the area is underway so the water drilling can be done. They are continuing with the shop drawings. There was an oil tank found on the property which had a leak. Mr. Miner said seventeen samples were taken around the tank and all samples were negative.

Construction Manager's Report Great Neck School: O & G

Mr. Mark Allen showed some slides of the property lines; the southeast corner, the east property line, and existing foundation looking north which showed that the area after all the rain was not draining well. He said the concrete is ready to go. The shop drawings will be looked at this week.
